1. GENERAL INFORMATION RELATED TO APPLICATION

1.1. Applicants:

TTA – Tütün, Tütün Mamulleri, Tuz ve Alkol İşletmeleri A.Ş., Koyuncu Nakliye Pazarlama and Tic. A.Ş. and Mutlucan Tuz Madencilik Turizm Petrol Nakliyat San. A.Ş applied for the extension of the safeguard measure on the imports of salts. Cihanbeyli Madencilik, Turizm, Nakliyat, Kimya San. A.Ş. also supports the application for the extension of the safeguard measure.

1.2. Domestic Producers

The applicants represent the important part of the domestic industry; the other producers are Oltu Mermer Mad. San. Tic. Ltd. Şti., Arif Potuk, Gökay İnşaat Tic. Ltd. Şti., Çan-Kaya Kaya Tuzu Nak. İnş. Tur. İth. İhr. San. Tic. A.Ş., Kristal Tuz Madencilik Petrol, Gıda. İnş. Tur. San. Tic. Ltd. Şti., Petrol Ürünleri Uluslararası Taş. İç-Dış Tic. A.Ş., Alkim Alkali Kimya A.Ş..

1.3. Customs Classification Numbers of The Product Subject to Application:

The product subject to application is salt for chemical transformation (separation of Na from CI) for the manufacture of other products classified under 2501.00.31.00.00, salt denatured or for industrial uses classified under 2501.00.51.00.00, pure sodium chloride classified under 2501.00.99.10.00, rock salt classified under 2501.00.99.90.11, saltpan salt classified under 2501.00.99.90.12 and sea salt classified under 2501.00.99.90.13.

But, the rock salt classified under 2501.00.99.90.11, saltpan salt classified under 2501.00.99.90.12 and sea salt classified under 2501.00.99.90.13 have been combined under Customs Tariff Position 2501.00.99.90.00 as "others" by a change done in 2009 in the Turkish Customs Classification.

2.1.Imports in Absolute Terms

The overall imports of the product subject to application has been continuously increased before being subject to measure, after the measure it has decreased compared to previous years. But, it has increased at a rate of 25 % in 2008 compared to the previous year.

There is not any change in the domestic production capacity related to the product subject to application. The capacity utilization ratio decreased to 65% by decreasing at a rate of 17% in 2008.

4. CONCLUSION

The total imports of the product subject to application decreased in the first year after measure; but increased at a rate of 25 % in 2008 compared to the previous year.

Despite the safeguard measure being implemented, it is seen that there is a decrease in production, domestic sales, inventories and capacity utilization ratios of the domestic producers in the evaluation period.

As a result, extension of the safeguard measure is requested by taking into consideration that the domestic producers are still in an adaptation period to the market conditions and several of them were privatized.
