ExxonMobil Mozambique Exploration and Production Limitada, (EMMEPL) invites interested internationally recognized environmental and geotechnical data acquisition contractors that are duly qualified to submit their expression of interest ("Expression of interest") to perform Environmental Baseline and Geotechnical Sampling and Testing Services. Services will be performed in the Angoche AS-B and Zambezi Z5-C and Z5-D exploration blocks offshore Republic of Mozambique.

## SCOPE OF WORK

The scope of work will include acquisition of deep water box cores, piston cores, water column testing and sampling, onboard sample logging and preparation and post survey laboratory testing and reporting to international analytical standards. Water depths in the study area range from approximately 1,000 to 2,500 meters. The following activities will be included:

- Acquisition, processing and laboratory analysis of box cores in
cluding physical/chemical and benthic infauna analysis
- Acquisition of water column profiles and water samples for physical / chemical analysis
- Acquisition, processing and geotechnical laboratory testing of $6-9 \mathrm{~m}$ long piston cores
- Data compilation and reporting
