GENERAL CONDITIONS OF PARTICIPATION

- $\ensuremath{\varepsilon}$ The deadline for submisson of Application is indicated in the Application form.
- The registered exhibitor can resign application without commitment to pay for rental charges, before the day of Fair's decision to accept the Application. After that deadline, the renter that submitted the application is obligated to pay rental sum.
- Once received the Application form, the Adriatic Fair distributes the place to the exhibitor. The exhibitor is obliged to prepare rented space for exhibiting at least until March 31st 2020 at 8 p.m.
- After the acceptance of the Application form, Fair sends the invoice calculated by the Application to the exhibitor.
- $\varepsilon\,$ For additional requirements and alterations already decorated stand is increased by 30%.
- $\ensuremath{\varepsilon}$ Invoice payment is condition for participation
- The payment is condition of participation. All exhibitors are obliged to show the proof of payment to the Fairs authorized staff before the exhibition.

- ← The amount for additional services and eventual difference between requested and
- assigned space are paid by the additional invoice immediately after receiving it.

 Opening hours of the exhibition defines by Menagement of Adriatic Fair. Working hours is from 10 a.m. 7 p.m. The exhibitor cannot abandon space until the last working day of the Fair ends.
- The exhibitor is not allowed to give another exhibitor a part or entire exhibition space without a permission of the Adriatic Fair.
- The insurance of the samples is at exhibitor's charge. The Fair is not responsible for the demages caused by disappearances, destruction or damages of the property during the exhibition at the Fair.
- Exhibition space has to be returned to Adriatic Fair in a condition in which was submitted to the exhibitor. Removal of materials, displayed exponents, equipment and all other objects bears the exhibitor.
- In the case of dispute of this Application-contract, the jurisdiction of the Commercial Court in Podgorica is agreed.
