(4) Cancellation fees

Should scheduled work be cancelled for reasons not attributable to the designated on-site cargo handler, provided that it is partially or completely cancelled at 3 p.m. or later of the day before the date on which the work is to be carried out as indicated on the Cargo Delivery Reservation (Confirmation) Ticket, which the logistics team had confirmed in advance:

(5) Application rules

- a. Tonnage for calculation takes 1,000 kilograms as 1 tonne for weight, and 1 square metre as 1 tonne for volume. Valid figures are rounded to 3 decimal places.

- b. The tonnage to be used to calculate charges is the one between weight and volume which has a greater value.
- c. For cargoes and work that apply to surcharges, a prescribed amount is added to the standard charge.
- d. Where multiple surcharges are due, each charging rate is applied to the standard charge to obtain each additional amount, and the sum of these amounts is added to the standard charge.
- e. The minimum tonnage is 1 tonne for calculation.
- f. Consult the designated on-site cargo handler for the procedures and fees of inspection and volume verification.
